The applicant and owner are solely responsible and liable for determining the location of property lines. The City assumes no responsibility for locating property lines.

405.5 DUMPSTER All dumpsters located in multifamily complexes, or at commercial or industrial uses, shall be enclosed within permanent walls or sight-obscuring fences and be located so that refuse trucks are completely off the public right-of-way when servicing.

300 DEFINITIONS FENCE, SIGHT-OBSCURING: A fence which is designated and constructed to be completely solid and completely screens one's view from any angle, (excluding wood or slatted chain link fencing). (Ord. 1994-27-O).

The property may be subject to the provisions of the HISTORIC PRESERVATION ORDINANCE and/or the FLOOD HAZARD ORDINANCE. The applicant shall be advised accordingly and also informed that the Dumpster enclosure permit CANNOT be approved until after approval has been obtained from the HISTORIC PRESERVATION COMMISSION or the CITY ENGINEER.
