The traditional meatless meal of pasta, froshi and pastries will be served in the parish center from 11:30 am until 3:00 pm.
- 33. Alderman Holt commented on a Memorandum from the Citizens for Rebuilding Rockford announcing an upcoming "Endorsement" News Conference for Sales Tax/Road Referendum, which will be held on Wednesday, March 14, 2007 at 10:30 am at the IBEW Hall, 6820 Mill Road.
- 34. Alderman Holt announced Justin Francis' last day, as City Council Page, would be tonight. Justin has served as City Council Page for over two years and was a tremendous asset to our City Council Clerk and City Council Members. He will be graduating from Auburn High School this spring and attending Rock Valley College in the fall. We wish him the best of luck in his future endeavors.
- 35. Alderman Holt, on behalf of Mayor Morrissey, presented a Proclamation proclaiming the week of March 12, 2007 to be "Irish Marching Society Week" in Rockford, Illinois and urged all citizens to recognize and support the Irish Marching Society's enthusiastic efforts to celebrate and preserve their Celtic Heritage.

- 36. Alderman Bell advised that he had received several phone calls concerning a possible watermain break in the area that borders Ogilby Road, West Street/Clifton, Montague and along the river. He requested the Aldermen be informed of these situations and asked Director Bittner to update him on this matter. Director Bittner advised he would fax this information to him tomorrow morning.
- 37. Alderman Bell commented he received correspondence from Chief Epperson regarding the apprehension of individuals involved in graffiti. He thanked him for the update and continued enforcement efforts. He suggested the City Legal Department and State's Attorney's Office coordinate efforts to adopt stringent requirements and disciplinary action to individuals arrested for graffiti.
